JOB SUMMARY

This is a skilled position within the Parks and Recreation Department. Work involves technical horticulture tasks associated with the planning, implementation, care, and maintenance of the planting beds within the City Parks and City owned areas. Provide technical guidance for the City's beatification in the parks, city owned areas, and Right of Way planting beds and pots. They will plan, direct, and coordinate with subordinate personnel.

- Plan, organizes, trains, and coordinates seasonal staff and equipment to conduct seasonal planting and maintenance activities in city owned beds and pots.
- Plan and Organize a seasonal maintenance program for the city owned plant beds and pots located in parks and city owned spaces including a management plan for weeds, pest, and disease control.
- Plans and Designs annual and perennial flower beds and pots
- Inventories, maps, and labels plant material for educational purposes in city owned areas.
- Organize and coordinate volunteer efforts within the parks, public spaces, and other city owned areas to assist with city beautification.
- Coordinate with partnered organizations and individuals maintaining beds and areas through the adopt-a-spot program.
- Organize environmental programs for the community such as gardening practices, seed ball making, and etc
- Performs building, special ground, horticulture, and general maintenance including mowing, trimming, weeding, and irrigation; caring for plants and trees.
- Performs all maintenance aspects of planting and growing perennial and annual plants located in park/city properties.
- Performs general maintenance activities in and around city facilities such as the cemetery, city hall, library, and over 70 flower beds.
- Operates a variety of equipment including mowers, sprayers, tillers, weed trimmers, pruning equipment, gas powered irrigation pumps.
- Performs related work as required.

- Growing of flowers from seed to planting.
- Overall care of all annual and perennial plants to include weeding, watering, fertilization, "dead heading" to increase survivability.
