FAQ for Virtual Fall Workshop



Registration fee

The event registration fee of \$30 for IPRA Member and \$40 for Non-IPRA Members includes all three (3) time slots per mini workshop. If you choose to not attend all three(3) time slots per mini workshop there is no pro-rated rates. You can register for one, two or all three mini workshops at one time. Registration for each workshop must be done at least three (3) business days prior to the event. There is also no pro-rated rates if you register for all three (3) mini workshops.

Choice of sessions

There will be two (2) presentations offered per time slot for members to choose from. A total of three (3) time slots per mini workshop will be offered. Each participant will receive a detailed one day schedule, 48 business hours prior to their registered event(s). This will include your virtual log in information and a more detailed description of the sessions being offered and presenter information. All participants will have the choice of which session they attend each time slot.

Log in required with video use
