The City of Grimes Parks and Recreation Department seeks three Sports Facilities Maintenance Workers, in newly created positions, to help provide clean, safe, and attractive sports facilities at the City of Grimes GrimesPlex and the North and South sports complexes.

Candidates should have general experience in the operation and maintenance of light and medium construction and maintenance equipment, particularly in the maintenance of parks and sports facilities. Commercial drivers' license, or ability and willingness to acquire CDL-B within 90 days and CDL-A within one year is required. Valid State of Iowa Commercial Pesticide Applicator's license - Categories 3OT - Ornamental and Turf Pest Control, or the ability to obtain the license within six months from the date of hire. Pay starts at \$23.34/hour with excellent benefits, and the City seeks **three** highly motivated candidates for these new positions.

C. Job Description Summary

Under the general supervision of the Sports Facilities Operations Manager, performs all necessary work, repairs, mechanical maintenance, and other duties to provide clean, safe, and attractive facilities at the GrimesPlex, North and South Sports Complexes. The nature of the work performed requires that an employee in this class establish and maintain effective working relationships with other City employees, outside contractors, sports clubs, and the public.

D. Routine Job Duties/Responsibilities

<p>Plans and conducts turf grass culture, renovation, and maintenance programs at the GrimesPlex, North and South Sports Complexes, including soil prep/conditioning, sodding, and seeding, watering, weeding, aerating, fertilizing, mowing/trimming, pesticide and herbicide selection and application and seed mix recommendation.</p>
<p>Plans, schedules, and follows through with routine daily work activities.</p>
<p>Operates pickup trucks with hydraulic trailers, dump trucks, tractors with attachments, gang mowers, generators, garbage compactors, tampers, portable power tools, power riding mowers, power hand mowers, leaf blowers, tillers, sod and weed cutters, augers, chain saws, edger's, sprayers, aerators, electronic sprinkler controls, and various hand tools such as shovels, rakes, hoes, clippers, and personal protective equipment.</p>
<p>Performs minor mechanical and maintenance service to assigned parks vehicles. Performs and documents daily equipment inspections in accordance with department policy.</p>
<p>Performs trash pickup, restroom cleaning, mowing and other facility and site maintenance tasks as assigned.</p>
<p>Assures that the City's missions, goals, and objectives are fully initiated and supported.</p>
<p>Ensures that safe and efficient work practices and procedures are followed, including those pertaining to the setup of a work site, the use of equipment, the maintenance and storage of equipment, materials and tools, and the use of personal protective clothing and equipment.</p>
<p>Expected to work outside of normal classification in the event of an emergency, winter snow event, or extreme weather or related event.</p>
<p>Performs other duties and responsibilities as assigned.</p>

E. Periodic Job Duties/Responsibilities

Attends safety meetings and seminars as required and promotes workplace safety. Follows all City and department safety policies and procedures. May work independently with minimal supervision or act as lead person on small crews.

F. Qualifications

Education/Experience:	High School Diploma or GED. General experience in the operation and maintenance of light and medium construction and maintenance equipment or additional skills, training or education.
Skills:	Ability to calibrate and operate turf sprayers and spreaders. Ability to evaluate product performance and recommend changes in product selection and/or application. Ability to follow written and oral instructions. Ability to drive truck
Knowledge	General knowledge of tools and equipment including heavy, hand/power and electronic and leadership certifications preferred. Knowledge of turf grass management in commercial, recreational or institutional setting
Licenses/Certifications:	Valid Iowa CDL-B for straight trucks over 26,000GVW with endorsements for air brakes and tanker within one month of employment. Ability to acquire valid CDL-A within one year of hire. For candidates without a current CDL, consideration will be given to candidates willing to acquire CDL-B within 90 days and CDL-A within one year. Valid State of Iowa Commercial Pesticide Applicator's license - Categories 3OT - Ornamental and Turf Pest Control, or the ability to obtain the license within six months from the date of hire.
Other:	Must be 18 years old.
