In addition to being an excellent source of information, *this workshop has been approved by the Iowa Department of Inspections, Appeals, and Licenses for 2.5 hours of continuing education* in accordance with part 641-15.11(2) of the Iowa Health Code which requires all Certified Pool Operators® to receive ten (10) hours of continuing education in a five (5) year period concurrent with the individual's CPO® certification. The simplest way to meet this requirement is to attend a CEU workshop annually. No CEU Workshop updates a person's Certified Pool Operator® license as issued by the Pool & Hot Tub Alliance.
